## NOBLE ANIMAL CONTROL

The best thing you can do for your dog or cat is to place collars and tags on them. **City of Noble Ordinance Section 4-201A**, requires all dogs and cats in Noble's city limits to be licensed through Noble Animal Control. License can be purchased from the Noble Police Department (includes a metal tag to be worn by your pet at all times). This allows an officer to immediately locate the animal's home and return him or her promptly. A current rabies tag issued by a licensed veterinarian should be worn as well.

### City of Noble Ordinance Section 4-102

It is unlawful for any domestic animal to be at large at any time within the City.

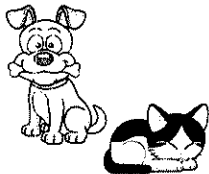
### City of Noble Ordinance Section 4-111D

A photo ID, a deposit of \$120.00, and a completed application are required prior to connection of services.

### UTILITY BILLING PENALTIES/CUTOFF DATES

If bill is not paid by close of business (4:30pm) on the 23rd of each month, a service/reconnect fee of \$25.00 and a possible additional deposit must be paid in order to continue service.

**NOTE:** Sanitation, Ambulance & Street Light Fees are billed by the month NO Pro-ration.

### DENIAL OF SERVICE TO A CUSTOMER

# City of Noble Automatic Bank Draft Payment Authorization

### What is Automatic Bank Drafting?

Automatic Bank Drafting allows you to pay your bills automatically by having payments withdrawn directly from your checking or savings account.

- \* You save time by not having to write checks for your bills.
- \* You save money on postage and bill paying supplies.
- \* You no longer have to worry about your payments being lost or about not being able to pay your bills while you are out of town.

### Enrollment is easy!

Simply complete the authorization form (see below) and mail it in along with a voided check to ensure accurate processing.

### How Automatic Bank Draft Works

You will still see your bills before they are paid. The City will send you a statement by mail before your bill is due. You will know the exact amount and the exact date your payment will be deducted from your account.

If you have questions regarding your bill, you will have ample time to call the City and resolve your concerns.

### TERMS AND CONDITIONS OF AUTHORIZATION

#### 1) AUTHORIZATION

Complete the Authorization Agreement for the bill payment program. **NOTE:** to ensure accurate information, please enclose a voided check with each authorization agreement.

#### 2) REVOCATION

This authority is to remain in effect until revoked by the customer, City, or financial institution. Customer must notify the City to discontinue the automated payment service.

#### 3) STOP PAYMENT

You have the right to stop payment of a charge by notifying your financial institution up to three (3) business days prior to the charging of your account

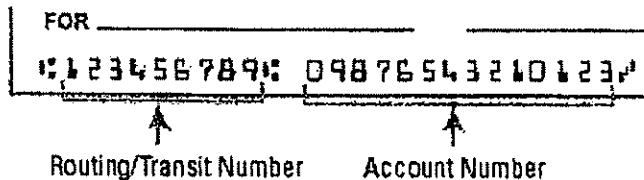


