

**CITY OF NOBLE ORDINANCE NO. 591**

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF NOBLE, CLEVELAND COUNTY, STATE OF OKLAHOMA AMENDING PART 5, CHAPTER 5, SECTION 5-515, OF THE CODE OF ORDINANCES OF THE CITY OF NOBLE BY PROVIDING A REQUIREMENT FOR REGISTRATION OF ELECTRICIANS WITH THE CITY OF NOBLE, PROVIDING THE QUALIFICATIONS FOR REGISTRATION, PROVIDING REGISTRATION FEES, AMENDING PART 5, CHAPTER 3, SECTION 5-304, PARAGRAPH B, PROVIDING FOR STATE LICENSING OF PLUMBERS, AND AMENDING THE FINE/BOND SCHEDULE OF THE CITY OF NOBLE, PROVIDING FOR SEVERABILITY, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF NOBLE, CLEVELAND COUNTY, STATE OF OKLAHOMA:**

**Section 1.** That **PART 5, CHAPTER 5, SECTION 5-515** of the Code of Ordinances of the City of Noble, Oklahoma, is hereby amended and shall henceforth read in its entirety as follows:

**Section 5-515. Registration of Electricians Required; Qualifications for Registration; Registration Fees.**

A. It is unlawful for any person to engage in the business, trade or occupation of an electrician contractor (otherwise known as a master electrician), or of a journeyman electrician, or of an electrician's apprentice, in this City unless he is registered with the City clerk and has a current and valid certificate of registration issued by the City clerk.

B. Only persons who have current and valid licenses as electrician contractors or as journeyman electricians issued by the Oklahoma Construction Industries Board may register as such with the City clerk. Only persons who have current and valid certificates of registration as electrician's apprentices issued by the Oklahoma Construction Industries Board may register as such with the City clerk.

C. The fees for a certificate of registration to qualified persons of each class shall accompany the application for registration. The registration fee shall be paid to the electrical inspector or authorized City employee before the issuance of a certificate of registration and only after the person has been approved by the state board. The following fees are applicable:

1. Master Electrician or Contractor License, One Hundred Dollars (\$100.00) for the first year and thirty-five dollars (\$35.00) for every year thereafter;
2. Journeyman License, Ten Dollars (\$10.00) for the first year and Five Dollars (\$5.00) for every year thereafter.

**Section 2.** That **PART 5, CHAPTER 3, SECTION 5-304, PARAGRAPH B** of the Code of Ordinances of the City of Noble, Oklahoma is hereby amended and shall henceforth read in its entirety as follows:

B. Only persons who have current and valid licenses as plumbing contractors or as journeyman plumbers issued by the Oklahoma Construction Industries Board may register as such with the City clerk. Only persons who have current and valid certificates of registration as plumber’s apprentices issued by the Oklahoma Construction Industries Board may register as such with the City clerk.

**Section 3.** That the following fines/bonds are hereby adopted for the following offenses in the City of Noble, Oklahoma, pursuant to 22 O.S. Section 1115.1, and the FINE/BOND SCHEDULE of the City of Noble, is authorized and directed to be changed accordingly by adding the below described offenses and fines to the Fine/Bond Schedule of the City of Noble, Oklahoma approved on August 1, 2018:

Section 5-515 of Noble Code of Ordinances	ELECTRICAL WORK PERFORMED WITHOUT REGISTRATION CERTIFICATE FROM CITY	\$500.00
Section 5-1101 of Noble Code of Ordinances	BUILDING CODE VIOLATION	\$500.00

Except as provided for herein, the FINE/BOND SCHEDULE of the City of Noble, Oklahoma, approved on August 1, 2018 remains unchanged.

**Section 4.** IF ANY SECTION, SUBSECTION, SUBDIVISION, PARAGRAPH, SENTENCE, CLAUSE OR PHRASE IN THIS ORDINANCE, OR ANY PART THEREOF, IS FOR ANY REASON HELD TO BE UNCONSTITUTIONAL OR INVALID OR INEFFECTIVE BY ANY COURT OF COMPETENT JURISDICTION, SUCH DECISION SHALL NOT AFFECT THE VALIDITY OF EFFECTIVENESS OF THE REMAINING PORTIONS OF THIS ORDINANCE OR ANY PART THEREOF.

**Section 5.** ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH ARE HEREBY REPEALED.

**Section 6.** IT BEING IMMEDIATELY NECESSARY FOR THE PRESERVATION OF THE PUBLIC HEALTH, PEACE AND SAFETY OF THE CITIZENS OF THE CITY OF NOBLE, OKLAHOMA THAT AN EMERGENCY BE DECLARED.

**WHEREFORE,** AN EMERGENCY IS HEREBY DECLARED TO EXIST AND THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT IMMEDIATELY UPON ITS PASSAGE, APPROVAL AND PUBLICATION.
