

CITY OF NOBLE ORDINANCE NO. 605

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF NOBLE, OKLAHOMA, REZONING THE REAL PROPERTY DESCRIBED HEREIN FROM C-1 (RESTRICTED COMMERCIAL) TO R-3 (MEDIUM DENSITY RESIDENTIAL) PROVIDING FOR SEVERABILITY; AND PROVIDING FOR THE DECLARATION OF AN EMERGENCY IF BY SEPARATE VOTE THE CITY COUNCIL DETERMINES THAT AN EMERGENCY EXISTS NECESSITATING THAT THIS ORDINANCE BE DECLARED TO BE EFFECTIVE IMMEDIATELY UPON ITS ADOPTION.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF NOBLE, OKLAHOMA:

SECTION 1. That the tract of real property described herein and located within the municipal limits of the City of Noble, Oklahoma, is hereby re-zoned at the request of Heisman Homes, LLC, the property owner and after notice to all parties entitled to notice according to law and formerly classified as C-1 (RESTRICTED COMMERCIAL) shall henceforth be classified as R-3 (MEDIUM DENSITY RESIDENTIAL) according to the Code of Ordinances of the City of Noble, Oklahoma.

R-3 (MEDIUM DENSITY RESIDENTIAL) ZONING IS HEREBY APPLIED TO THE FOLLOWING PLATTED LOTS:

Lots 12A and 13A of the Noble Plaza Addition to the City of Noble, Cleveland, County, Oklahoma, being a part of Section Twenty-two (22), Township Eight (8) North, Range Two (2) West, I.M., Cleveland County, Oklahoma (112 Woodbriar Road).

SECTION 2. Provisions Severable.

The provisions of this ordinance are severable and if any section, subsection, subdivision, paragraph, sentence, clause or phrase or any part thereof is for any reason determined to be unconstitutional or adjudged invalid or ineffective by any Court of competent jurisdiction, such determination or adjudication shall not affect or impair the validity or effectiveness of the remaining parts, provisions or portions hereof.

EMERGENCY CLAUSE

WHEREAS, it being immediately necessary for the preservation of the peace, health, welfare and safety of the City of Noble, Oklahoma, and the inhabitants thereof that the provisions of this ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof, this ordinance shall take effect and be in full force from and after its passage as provided by law.
