



NOBLE UTILITIES AUTHORITY (NUA) RESIDENTIAL APPLICATION & SERVICE AGREEMENT

**REQUIREMENTS TO START SERVICE:**

- 2 forms of federally recognized identification.
- \$120 Deposit in Cash, Check, or Money Order ONLY.
- Signed application/service agreement.
- Copy of Property lease or deed.

UTILITY BILLING, PENALTIES & CUT OFF DATES:

- 1st Bills mailed
- 15th Payment due
- 16th 10% Penalty & FINAL NOTICES mailed
- 23rd Payment with penalty due
- 24th Service **DISCONNECTED** without further notice.

NOTE: If the bill is not paid by the close of business (4:30pm) on the 23rd of each month, a service fee of \$25.00 and a possible additional deposit must be paid in order to reconnect service.

NOTE: Sanitation, Ambulance, & Street light are billed by the month and WILL NOT be pro-rated.

DENIAL OF SERVICE TO CUSTOMER: Service may be refused by NUA to an applicant when there remains an unpaid account balance for services previously provided to applicant. Also, NUA shall not be required to provide service to an applicant who uses an alias, trade name, business name, or the name of a relative or other person to escape payment of an unpaid utility account.

DELINQUENT ACCOUNT TURNED OVER TO COLLECTION AGENCY: If any delinquent account is turned into collections or attorney, or if suit is filed, all costs and attorney fees associated therewith, fee, costs, and expenses, shall be added to the delinquent amount and collected as part of the delinquent account.

IMPORTANT SEWER INFORMATION: If you suspect a problem with the city sewer main line, please call 405-872-9251 during normal business hours (MON-FRI 8:30A-4:30P). For emergencies after hours call the Noble Police Department at 405-872-9231 for assistance. NOTE: The City of Noble is NOT responsible for private services or for any plumbing contract expenses ordered by the resident.

NOBLE ANIMAL CONTROL

The best thing you can do for your dog or cat is to place collars and tags on them.

City of Noble Ordinance Section 4-201A, requires all dogs and cats in Noble's city limits to be licensed through Noble Animal Control. License can be purchased from the Noble Police Department (includes a metal tag to be worn by your pet at all times). This allows an officer to immediately locate the animal's home and return him or her promptly. A current rabies tag issued by a licensed veterinarian should be worn as well.

City of Noble Ordinance Section 4-102

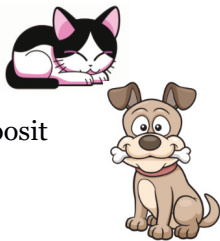
It is unlawful for any domestic animal to be at large at any time within the City.

City of Noble Ordinance Section 4-111D

Allows two (2) dogs per residence.

2 Ids (1 photo ID), a deposit of \$120.00, and a completed application are required prior to connection of services.

Utility Billing Penalties/Cutoff Dates

- 1st Bills are mailed
 - 15th Payment is due
 - 16th 10% Late penalty assessed/
 - 24th Final Notices Mailed
- DISCONNECTION without further notice

If bill is not paid by close of business (4:30p) on the 23rd of each month, a service/reconnect fee of \$25.00 and a possible additional deposit must be paid in order to continue service.

NOTE: Sanitation, Ambulance & Street Light Fees are billed by the month and not pro-rated.

DENIAL OF SERVICE TO CUSTOMER

Service may be refused by the city to a customer when there remains an unpaid account for services previously provided. The city shall not be required to provide service to an applicant who uses an alias, trade name, business name or the name of a relative or other person as a device to escape payment of unpaid utility bill of any other person a previous customer with an unpaid account remains an occupant or user of the customer.

DELINQUENT AMOUNT TURNED OVER TO COLLECTION AGENCY

If any delinquent account is turned over to collections or an attorney, or if suit is filed, all attorney fees associated therewith, fees, costs, and expenses shall be added to the delinquent amount and collected as part of the delinquent account.
